A late Obama era expansion of the RMP standards has survived challenges and went into effect in 2019. An estimated 5 million workers are required to wear respirators in 1.3 million workplaces throughout the United States. OSHA's respiratory protection standard requires employers to establish and maintain an effective respiratory protection program when employees must wear respirators to protect against workplace hazards. Participants in this webinar can expect to learn about respiratory protection program administration, employee training, medical evaluation and fit testing, respirator use, and other key aspects of OSHA's respiratory standard, as well as OSHA guidance and enforcement pertaining to respiratory protection.
