His experience includes representing developers and property owners in zoning, permitting, and land-use litigation, including litigation under the Massachusetts state zoning act (chapter 40A), state hazardous-waste laws, wetlands laws, waterways laws, and other federal and state environmental statutes and regulations, as well as handling a wide range of general business litigation. Dylan also has experience in product-liability matters, including cases involving consumer products mass torts, in addition to professional-malpractice defense.

Dylan has extensive experience practicing in federal and state courts, including the Massachusetts federal courts, the state's Land Court and superior courts, and the Massachusetts Court of Appeals and Supreme Judicial Court. Department of Environmental Protection*, 474 Mass. 278 (2016), and most recently *Armstrong v. Secretary of Energy and Environmental Affairs* 490 Mass. 243 (2022).
