Maddie began as an Associate in the firm's Washington, DC office in 1999. In 2005, after returning to Texas, she co-founded the Austin office and served as its first Managing Principal. She is the immediate past Chair of the firm's International Environmental Practice Group and the immediate past Co-Chair of the Air and Climate Change Practice Group.
