Enforcement Defense

Permit Defense

- Landfill Represented major waste management company in challenge to landfill expansion permit. Prevailed at week-long evidentiary hearing and defeated all challenges.
- Power Plant Represented energy company in challenge to air permit for natural gas power plant. Reached favorable settlement with plaintiffs.
- Landfill Defense of major waste management company in challenge to landfill permit. Secured favorable settlement, resolving all challenges prior to evidentiary hearing.
